ELIGIBLE RISKS

- Psychiatrists – Individual practitioners as well as groups
- Office-based practices, but will consider hospital or other health facility employed psychiatrists that purchase insurance separately

FEATURES & HIGHLIGHTS

Allied World's policy provides claims-made protection with a duty to defend against any professional liability claims arising from treatment-related events (including any defamation related to such treatment). Coverage for treatment-related events that happened prior to the policy is also available (i.e., "prior acts").

Primary coverage is available for the following key exposures:

- **Professional Liability** – Provides coverage for claims if sued for professional negligence or misconduct (including sexual misconduct) in providing or failing to provide professional services, including peer review.
- **Premises Liability** – Provides coverage for an injury or damage sustained at your business premises that does not qualify as a professional liability.

Costs Related to Proceedings –

Reimbursement for the costs to defend a hearing or disciplinary action before a state or other licensing board or government body.

OTHER KEY BENEFITS

- Payment of Defense Expenses is in addition to the Limit of Liability
- Broad definition of Insured includes the business entity and any present or former partner, executive officer, director, stockholder or employee
- Broad definition of Claim allows coverage for reported incidents that have not yet resulted in actual claims
- Reimbursement for up to \$250 per day/\$5,000 aggregate each claim for loss of earnings resulting from being away from your practice at the insurer's request to assist in defense of claims
- Premium for extended reporting period is waived if due to death or permanent disability
