ELIGIBILITY 投保資格：

Eligibility for the extension(s) is subject to the criteria as set by the Government of Hong Kong SAR for the "Northbound Travel for Hong Kong Vehicles" scheme, as amended from time to time, including but not limited to:

- Hong Kong private cars registered by individuals only;
- Body length of the private car must not exceed 6 meters and seating capacity must not exceed 8;
- The private car is used for social, domestic and pleasure purposes or for the proposer's business or profession only (i.e. not for hire or reward); and
- The private car may only spend up to 180 days per year in Guangdong Province and up to 30 consecutive days each time.

伸延保障的投保資格根據香港特別行政區政府為「港珠澳大橋港車北上」計劃所制定的標準（經不時修訂），包括但不限於以下內容：

- 只限於以個人名義登記的香港私家車；
- 私家車車身長不可超過 6 米及座位數目不可超過 8 個；
- 私家車只可作社交、家庭、娛樂或投保人的業務或職業用途（不得作出租或收費接載用途）；及
- 私家車每年只可在廣東省逗留最多 180 天，每次可連續逗留最多 30 天。
